New Integrated Steel Plant in Brazil, TKCSA

Project Description

From the beginning of the year 2006 until the provisional completion in June 2010 a new integrated steel plant was built in Brazil for ThyssenKrupp CSA Companhia Siderúrgica do Atlântico (TKCSA), in which ThyssenKrupp Steel Europe with 73% and the Brazilian iron ore supplier VALE S.A. with 27% are involved. The plant is located 70 kilometers from the city center in the western zone of the metropolis Rio de Janeiro, Sepetiba Bay in the state of Rio de Janeiro. The plant consists of a sinter plant, two blast furnaces, a steel plant, two continuous casters as well as a private sea port and a power plant. According to original plans five and a half million tons of steel slabs per year should be produced in this plant for export to the USA and Europe. Caused by technical problems to date, the plant, where about 3500 people work, has not powered up to full load yet.

It is the largest German investment abroad for the last 10 years in Brazil.


